SPRING MEETING MINUTES MARCH 24, 2007 JEANNIE WOMACK PARK

Michael Jones commenced the meeting at 4:07p.m. In attendance were: Sharon Sergeant, Dan Walsh, Anabel Crouch, Mike Massaro, Carlos Quiroz, Andrew Page, Sgt. Paul Kent, Officer Derrick Metzger, Patti Ransdell, Todd Eberle, Dan Breg, Tim Treichert, Michael & Teresa Jones, Mitch Jang, Todd Eberle motioned to waive the reading of the 9/16/06 meeting minutes, Mitch Jang 2nd and carried unanimously. Teresa read the Treasurer's report. February ending balance was \$597.08. Mitch motioned to accept Treasurer's report and Dan Walsh 2nd. Unanimous vote to accept. All in attendance introduced themselves. Michael passed out Residential Security Check Applications which are applications that residents file with the Police Department prior to departing for vacation, trips, extended periods away from home. The application covers specifics such as emergency contacts, lights, pets, mail, etc. This is a great tool for residents to utilize during absences from their homes.

Michael introduced Sgt. Paul Kent from the Sacramento Regional Office of Homeland Security, Regional Terrorism Threat Assessment Center, (RTTAC) and Officer Derrick Metzger from Elk Grove P.D., Terrorism Liaison Officer, and (TLO). Sgt. Kent works in

Homeland Security at a Federal, State & Local level with regards to terrorism and disaster preparedness. Sacramento area is one of the best trained areas regarding disaster preparedness. Elk Grove has a full functioning mobile unit for de-con, (decontamination); should the need arise. Elk Grove has 8 Terrorist Attack Officers, (TA). There is 1 TA officer for every shift plus patrol officers. Every person should carry with them a disaster preparedness backpack containing the following: running shoes, socks, t-shirt, sweatshirt, food such as peanuts and a granola protein snack, two water bottles, (one for drinking, one for rinsing eyes), work gloves, flashlight, sharpie pen, and a multi-use knife. This backpack should stay with you at all times, not be left in the car. Michael thanked Sgt. Kent and Officer Metzger.

Michael introduced Andrew Page and Patti Ransdell, Sacramento County South Interceptor. Andrew explained that the South Interceptor will be gravity feed sewage lines anywhere from 15 to 30 feet deep that will connect the newer Elk Grove neighborhoods south of Elk Grove Blvd. to the waste treatment facility on Franklin Blvd. These neighborhoods are currently operating on temporary pumping stations that the builders have provided. Once connected these temporary pumping stations will be turned off and abandoned. The project is scheduled go to bid in late 2008. Construction for the

South Interceptor will begin in 2009 and continue through 2010 which is approximate two year duration. Construction will be tunneling in nature. The lines will run from just south of the Franklin Library on Franklin High Drive north to Whitelock Pkwy west to Franklin Blvd., north to Elk Grove Blvd., west to the rail road tracks and north along the tracks to the waste treatment facility. Some of our resident's properties will be affected along the Elk Grove Blvd. path. These residents have already been contacted by Sac County and are currently negotiating resolve.

Michael thanked all our guests and residents and adjourned the meeting.
